PRIVACY POLICY

- 1. We respect your privacy
 - 1.1. California Tacos respects your right to privacy and is committed to safeguarding the privacy of our customers and website visitors. We adhere to the Australian Privacy Principles contained in the Privacy Act 1988 (Cth). This policy sets out how we collect and treat your personal information.

2. Collection of personal information

- 5.5. We would seek to only disclose information in good faith and where required by any of the above circumstances.

6. Security of your personal information
